If you have been in close contact with a person infected with COVID-19

Dear Students,

In Shizuoka Prefecture, since March 28, 2022, Public Health Center (保健所[hokenjo]) determine person who share a living space with an infected person (correspond to A in the table below) as a close contact person, but person who meet the conditions B to E in the table below is not determined as a close contact person by Public Health Center and do not have to take in self-isolation at home.

If you meet the condition A to E in the table below, please follow the following detail.

1. Meet the condition A in the table below

-Submit your symptoms and other information using the Coronavirus disease (COVID-19) report web form on the university homepage as soon as you are determined as a close contact person.

-Stay at home according to the instructions from the Public Health Center.

-You are not allowed to attend classes. It will be not deemed as absence. (However, you have to submit your symptoms and other information using the Coronavirus disease (COVID-19) report web form as mentioned above and submit the health check sheet.)

2. Meet the condition B to E in the table below

(1) If you do not have any symptoms such as fever and cough

-You are allowed to attend classes but it will be deemed as absence as usual. (No consideration for your absence)

- Monitor your health and record your temperature until 7 days after you were last exposed to the infectious person.

-If you have any questions or concerns, you can consult with Shizuoka University Health Care Center.

(2) If you have symptoms such as fever and cough (Including the

case that you start showing any symptoms even though you do not have any symptoms at first.)

-Do not come to campus. (If you start showing any symptoms such as fever, cough or other symptoms after you come to campus, leave campus immediately.) Consult your family doctor immediately. If you do not have a family doctor, call Fever Consultation Center and visit the hospital you are guided by the Fever Consultation Center.

-Submit your symptoms and other information using the Coronavirus disease (COVID-19) report web form on the university homepage

-You are not allowed to attend classes. It will not be deemed as absence. (However, you have to submit your symptoms and other information using in the Coronavirus disease (COVID-19) report web form as mentioned above and submit the health check sheet which confirmed by student affairs section of your faculty.)

What is “Close contact” ?

If you have come into close contact with infected person starting 2 days before the infected person start showing symptoms (or two days before the infected person test if the person do not have symptoms), and meet the following any conditions.

A: A person who lives with the infected person

B: A person who had a conversation with the infected person without wearing mask within touching distance (1meter)

C: A person who had been in contact (e.g., talking, eating, drinking) with the infected person for more than 15 minutes without wearing mask, although you keep distance that does not touch each other (1 to 2 meter).

D: A person who had been with infected person in poor ventilation place regardless of the distance from the infected person.

E: Any other person who had been with infected person without prevention of COVID-19.
